

## **Agreement Policy**

It is mandatory for each participant to read, understand and sign the below document in order to take part in any activity associated with Lone Wolf Gaming. Please read the following document and be prepared to sign the day of the event. If you have any questions or concerns, please feel free to reach out to us.

I affirm that I have been advised of the inherent hazards and risks associated with this activity generally referred to as laser tag. I acknowledge that the activity is physically and mentally challenging and that I do not suffer from any illness, ailment or infirmity that would preclude me from safely participating in the activity. When the activity is played outdoors, there is the additional risk of uneven terrain, slippery terrain, poisonous plants, stinging and biting insects and other forces of nature and wildlife which are beyond the control of the Operator. Despite these and other risks, and fully understanding those risks, I warrant to the Operator that I wish to play laser tag and assume total responsibility for any risk or injury while participating in the activity. I am aware that the Operator does not warrant the condition or safety of equipment, facilities or premises, natural and constructed, or the availability of emergency medical care. I acknowledge that the forgoing waiver is intended to be as broad and inclusive as is permitted by the law of the State of New Jersey, and that if any portion thereof is held to be invalid, the balance shall, nevertheless, continue in full legal force and effect.

### **RELEASE & DISCHARGE**

The participant releases, discharges, waives and forever holds harmless Lone Wolf Gaming for all claims for any loss sustained by the participant whether caused by negligent act or willful act or omission, breach of contract, breach of statutory duty or otherwise in connection with Lone Wolf Gaming. I hereby for myself, heirs, executive administrators, successors and assignees, RELEASE and FOREVER DISCHARGE from any claims, liabilities, costs (including legal costs), damages, suits arising out of, connected with, or resulting from playing laser tag the operator, staff and the owners of the property upon which the activity is played.

### **USE OF PHOTOS/IMAGES/VIDEO**

The participant agrees to allow Lone Wolf Gaming to take photographs or other images while participants are playing laser tag and to develop, reproduce and use them royalty free for any purpose (including commercial advertising). Participant gives authorization to Lone Wolf Gaming and its agents or employees to seek medical attention for the participant in case of an injury.
